Committee Reports

<u>Finance Committee Report - Hanan Bowman</u>: The new treasurer will be meeting with the Finance Committee to start putting the 2025 budget together.

Landscaping Report - Gene Miller:

- There is a main water leak behind 1808 Nova Glen. On Tuesday the landscaping company will work to find the leak.
- A very large stump in common ground which is causing damage to 1802 Lynx Glen needs to be removed. Gene made a motion to have it removed at a cost of \$500.00. Motion was seconded and approved by voice.

- The one-time a week visit for gophers was only through May. Weekly visits for gopher control will be reinstated.
- Squirrels are encroaching properties at the south end of Palo Glen. Gene will check with our landscaping company to see what they can do and at what cost.

Architecture: Spunk – There were three requests this month:

- Lot 93 Put in new plants.
- Lot 64 Replace dry rot and gutter on garage. Change out four windows.
- Lot 62 Put a deck in front next to the carport.

<u>Safety & Security – Jeff Jackson:</u>

- The Board decided that it would not be practical to put a lock on the front water spigot since it has only been misused two times at this point. If you notice a person parked in front of the clubhouse, using our water to wash their vehicle, please take a picture(s) if possible.
- We were all reminded again to just say "no" to solicitors.
- There is still a need for volunteers for Nutmeg and Clubhouse Monitor. The sign-up sheet was passed around.

Clubhouse Reservations - Betty Biggs: -- There are three reservations for July: 20th, 21st, and 27th.
